Request for Information about William Wildman Campbell

This document consists of a series of papers stemming from a request from the U. S. Congress's Joint Committee on Printing for details of the life of William Wildman Campbell.

Mr. Campbell was a Representative from the State of Ohio in the 59th Congress (1905-1907); father of John Wood Campbell and grandfather of Laura Philinda Campbell Krieg,


- Page 2, 1941-06-23: Letter from Ansel Wold, Clerk, Congress of the United States, Joint Committee on Printing; to The Superintendent, Forest Hill Cemetery, Napoleon, Ohio.
- Page 3, 1941-06-26: Letter from C. Harrison to Ansel Wold, explaining that he was forwarded the request for information by Mr. Kohlman, Superintendent of the cemetery. He, in turn, is forwarding the request to John W. Campbell in New York; he sends a few interesting details of Laura Philinda's life at the same time.
- Pages 3-7, 1941-05-06: Four-page pink form in booklet format for submission of biographical information. Attached to the second page of the form (page 4 of this document) is the carbon copy of a biographical sketch, presumably written by John Wood Campbell. The final page also contains requested details about W. W. Campbell's post-congressional career.
- The envelope addressed to J. W. Campbell is on file, though the return address is torn off.

CAMPBELL, WILLIAM WILDMAN, a Representative from Ohio; born in Rochester, Windsor County, Vt., April 2, 1853; attended the public schools, Goddard Seminary, Barre, Vt., and Tufts College, Medford, Mass.; studied law; was admitted to the bar in 1878 and commenced practice at Napoleon, Henry County, Ohio; served as prosecuting attorney for Henry County, 1893-1896; elected as a Republican to the Fifty-ninth Congress (March 4, 1905-March 3, 1907); unsuccessful candidate for reelection in 1906 to the Sixtieth Congress and for election in 1908 to the Sixty-first Congress; resumed the practice of law in Napoleon, Ohio; member of the State constitutional convention of 1911 and 1912; died in Napoleon, Ohio, August 13, 1927; interment in Forest Hill Cemetery.

Mr.Kohlman, Superintendent Forest Hill Cemetery, just handed me your letter of June 23rd.1941, and I am sending it to his son, Mr.John W. Campbell, 195 Broadway, New York, an official of the A.T.& T.Co. who no doubt will be able to furnish you with the desired information.

A very interesting coincidence is, that I just today, June 26th. received a letter from LAURA PHILINDA CAMPBELL, who is a grand-daughter, of Wm.W. Campbell, from HOTEL NETTO, Sintra, Portugal.

Laura Philinda, was a student in Paris, in Sept. 39, when the present war broke out: Instead of accepting the oppertunity of returning home to New York, she married, JAMES ARTHUR JONES, of Alabama, who was with the United Press, in Paris.

He joined the U.S.Embassy, in May 1940, and has been with them ## since, changing the Paris address for the one in Portugal, upon the request of the Germans.

Jimmie is a graduate of Northwestern Univ.1937, he is convicing, aggressive and has plenty of ability: Laura, is beautiful, 20 years old, and they are having a marvellous experience, mixed with numerous hard ships: they speak English, good French & Spanish.

Just at present, they are a little fearful that a cut in the Foreign Service, might affect them, because of his rather brief experience of from May 1940 to date— Really some thing should be done to prevent any thing of that kind.

Both Jimmie and his father, who is a Sate agent for a Casualty Insurance Co.at Jacksonville Fl. are good Democrats.

JOHN WILKINSON SMITH (son of George Edward Smith), a Representative from Pennsylvania; born in Lebanon, Pa., September 18, 1825; attended the public schools, the Belleville Business College, Belleville, Ill., and was graduated from Marshall College, Pennsylvania, in 1843; studied law, was admitted to the bar in 1846, and commenced practice in Columbus, Nev.; prosecuting attorney for Lebanon County, 1847-1849; member of the State house of representatives, 1850-1851; served in the State senate, 1854-1856; moved to Minneapolis, Minn., in 1856, and resumed the practice of law; elected as a Republican to the Thirty-sixth and Thirty-seventh Congresses (March 4, 1859-March 3, 1863); resumed the practice of law in Lebanon; elected Governor of Maine in 1870; again practiced law in Lebanon; died in Chicago, Ill., June 16, 1885; interment in Roselawn Cemetery, Springfield, Ala.
